QUARTERLY STATEMENT OF PRODUCTION, DEVELOPMENT AND EXPLORATION

JUNE 2006

PREMIER

PRODUCTION

Overburden movement was 6 per cent lower than the previous quarter, due to lower equipment availability.

Coal production for the quarter was 870,000 tonnes, 7 per cent below the previous quarter also due to lower equipment availability.

For the year ended June 2006, coal production was 3,713,000 tonnes, 12.3 per cent higher than the prior year.

DEVELOPMENT

The construction of the Research and Development 50,000 tpa Char Plant continues and commissioning remains scheduled to commence in the fourth quarter of this calendar year.

EXPLORATION

There was no significant exploration activity during the quarter.

CURRAGH

PRODUCTION

Overburden removal was 9.7 per cent higher than the previous quarter due largely to increased production from both draglines and contractor truck and shovel activity.

Coal production for the quarter was 2,383,000 tonnes (comprising 1,790,000 tonnes of metallurgical coal and 593,000 tonnes of steaming coal), 10 per cent higher than the previous quarter. Metallurgical coal production was 17.7 per cent higher than the previous quarter, due primarily to continued improvements in Coal Handling & Preparation Plant performance.

For the year ended June 2006, coal production was 8,945,000 tonnes (comprising 6,300,000 tonnes of metallurgical coal and 2,645,000 tonnes of steaming coal), 27.3% higher than the prior year. Metallurgical coal production was 38.9% higher than the prior year.

DEVELOPMENT

Key project development activities included continuation of the Curragh North Materials Handling Project, which at the end of the quarter was 70% complete with commissioning still scheduled for the fourth quarter of this calendar year. The forecast total cost of the Curragh North Project remains within the budgeted \$360 million.

EXPLORATION

Exploration drilling to further delineate the resource at Curragh North continued through the quarter.

BENGALLA

PRODUCTION

Wesfarmers' share of coal production for the quarter was 562,000 tonnes, 29.2 per cent higher than the previous quarter due to dragline operations progressing through a more productive section of the mine sequence characterised by thicker coal seams and lower rehandle, together with increased production from the contract mining operation in the Mt Arthur pit.

For the year ended June 2006, Wesfarmers' share of coal production was 2,301,000 tonnes, 6.2 per cent higher than the prior year.

DEVELOPMENT

Planning and evaluation continued with a view to obtaining approvals necessary to increase the maximum annual run of mine production from 8.7 million tonnes to 10.7 million tonnes.

EXPLORATION

There was no significant exploration activity during the quarter.
