DIVIDEND INVESTMENT PLAN ALLOCATION PRICE FOR 2018 FINAL DIVIDEND

Wesfarmers Limited today announced that the allocation price for shares to be issued through the Dividend Investment Plan for the final dividend to be paid in respect of the period ended 30 June 2018 is \$51.3833.

The allocation price for shares issued has been determined in accordance with the rules of the Dividend Investment Plan. For the 2018 final dividend, the allocation price was calculated as the average of the daily volume weighted average price of Wesfarmers Limited shares, excluding trades which are not considered to reflect normal supply and demand, on each of the 15 consecutive trading days during the period from 24 August to 13 September 2018 inclusive.

Based on audited data, shareholders representing 8.68 per cent of Wesfarmers Limited shares on issue had a valid election to participate in the Dividend Investment Plan for the period.

Shares are expected to be issued to participants in the Dividend Investment Plan on 27 September 2018.
