Quarterly Statement of Production, Development and Exploration

DECEMBER 2008

Premier

Production

Overburden removal was 31.3 per cent higher than for the previous quarter, during which seasonal wet weather had constrained operations.

Coal production for the quarter was 845,000 tonnes, 9.9 per cent lower than for the previous quarter. This reflected lower demand from Verve Energy, primarily due to a major scheduled upgrade at Verve's Muja Power Station.

Development

There was no significant development activity during the quarter.

Exploration

There was no significant exploration activity during the quarter.

Curragh

Production

Overburden removal was 1.7 per cent higher than for the previous quarter, due to increased truck and shovel activity.

Coal production for the quarter was 2,493,000 tonnes (comprising 1,756,000 tonnes of metallurgical coal and 737,000 tonnes of steaming coal). Metallurgical coal production decreased by 2.9 per cent compared to the previous quarter as a result of changes to the mining sequence and product mix. Steaming coal production decreased by 4.8 per cent in line with contractual requirements.

Development

Curragh continues a feasibility study into expanding the mine to achieve annual export tonnages of between 8.0 and 8.5 million tonnes of metallurgical coal.

Exploration

There was no significant exploration activity during the quarter.

Bengalla

Production

Wesfarmers' share of coal production for the quarter was 560,000 tonnes, 7.9 per cent higher than the previous quarter, due to operating in a more productive part of the mine sequence.

Development

Feasibility studies to determine the viability of increasing ROM production from 8.7 to 10.7 million tonnes per annum are continuing.

Exploration

There was no significant exploration activity during the quarter.
