Quarterly Statement of Production, Development and Exploration

CURRAGH

Completion of the sale of the Curragh Mine to Coronado Coal Group occurred on 29 March 2018.

Production

Overburden removal for the quarter ended 29 March 2018 was 2.9 per cent above the previous quarter.

Coal production for the quarter was 2,869,000 tonnes, 3.5 per cent below the previous quarter. Metallurgical coal production of 2,085,000 tonnes was 4.9 per cent above the previous quarter. Steaming coal production of 784,000 tonnes was 20.5 per cent below the previous quarter.

For the 12 months to 29 March 2018, metallurgical coal production decreased by 1.1 per cent to 8,231,000 tonnes and steaming coal production increased by 1.7 per cent to 3,672,000 tonnes.

Development

There was no significant development activity during the quarter.

Exploration

There was no significant exploration activity during the quarter.

Production

Wesfarmers' share of coal production for the quarter was 808,000 tonnes, 17.9 per cent below the previous quarter as the mine progressed through a less productive area of the mining sequence. For the 12 months to 31 March 2018, Wesfarmers' share of coal production increased by 11.7 per cent to 3,647,000 tonnes.

Development

There was no significant development activity during the quarter.

Exploration

There was no significant exploration activity during the quarter.
